We write to present the following Update on the captioned matters.

- (1) Hutti Block Prospecting Licence (PL) applications – Interim Application lodged before the Hon'ble Supreme Court:

In continuation of our Update made on July 9, 2019 our Lawyers have informed us that the Notice to the Respondents (Government of Karnataka) has been issued and dispatched by the Supreme Court Registry on July 12, 2019. Upon completion of service of Notice on Respondents, our Lawyers would be taking necessary steps to seek an earlier listing of the matter before the Hon'ble Supreme Court.

We shall promptly update the shareholders of further developments in this regard.

- (2) Ganajur Mining Lease (ML) application awaiting issue of Grant Notification Letter from Government of Karnataka – lodging of contempt proceedings:

We advise that our Lawyers have lodged Contempt Proceedings before the Hon'ble High Court of Karnataka against the Secretary, Commerce & Industries Department, Government of Karnataka (C & I) for willful disobedience of the Order dated March 21, 2019 (certified copy released on April 15, 2019) passed by the Hon'ble High Court.

Apart from multiple meetings with C & I post the aforesaid Court Order, Deccan Exploration Services Private Limited (DESPL), our subsidiary, had sent two reminders on May 3, 2019 and June 3, 2019 respectively seeking early issue of Grant Notification Letter and subsequent execution of Ganajur Mining Lease. Subsequently, our Lawyers had sent a Contempt Notice on June 18, 2019 seeking early resolution in the matter and intimating that contempt proceedings would be initiated in case there is no positive action forthcoming from C & I within a period of 10 days of receipt of the Notice.
