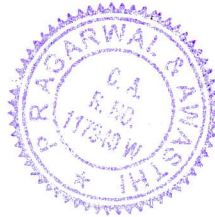
1. The certificate is issued in accordance with the terms of our engagement letter dated 17.09.2021.
