**Sub.: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015**

We write to present an Update on the following matters.

**1. Ganajur Mining Lease (ML) application of our wholly-owned subsidiary viz., Deccan Exploration Services Private Limited (DESPL) - filing of Amendment Application to Writ Petition No 17018/2021 filed before the Hon'ble High Court of Karnataka**

1.1 The captioned Writ Petition was listed before the Hon'ble High Court of Karnataka yesterday i.e., July 19, 2022.

1.2 Our Legal Counsel submitted to the Court that we have filed an Amendment Application to our captioned Writ Petition wherein we deleted the portions relating to challenging the constitutionality of the amendments made to Section 10A(2)(b) by the MMDR Amendment Act, 2021 and have incorporated the salient features of the favourable Judgment dated 27/05/2022 passed by the Hon'ble High Court in an identical matter in Indocil Silicons Pvt., Ltd., & Ors. Vs. Union of India & Ors .

1.3 After hearing our submissions, the Hon'ble High Court was pleased to fix the matter for further hearing after 4 weeks. Further, the Hon'ble High Court directed that their interim order shall continue in the meantime. It may be noted that at the hearing held on December 17, 2021 the Hon'ble High Court had directed the Respondent State not to take any precipitative action against the petitioner (DESPL) as was ordered by it in an identical case in WP No. 1920/2021 (Indocil case referred to above).


1.4 For more details on the subject, shareholders are encouraged to refer to our earlier Update made on June 29, 2022.
