Update on Tanzanian PL Blocks held by our subsidiary company viz., Deccan Gold (Tanzania) Private Limited (DGTPL)

We are pleased to report that we are shortly commencing geological mapping, litho-geochemical sampling followed by geophysical surveys in the 5 Prospecting Licence (PL) Blocks that our subsidiary viz., Deccan Gold (Tanzania) Private Limited (DGTPL) holds in Tanzania. The target areas have been prioritized based on the known geological potential.

The proposed study could reveal potential targets for further detailed exploration and drilling. Based on the results of the current work program which is expected to be completed within the next two months, we will plan the next phase of work.

We also write to intimate that DGTPL has paid the 2<sup>nd</sup> year's annual rent in respect of the aforesaid 5 PL Blocks in Tanzania to the mining authorities. Further, the statutory geological reports in respect of these PL Blocks have also been lodged with the mining authorities for the quarter ended March 31, 2022.

By way of background, shareholders may note that the Company incorporated a subsidiary company under the name of "Deccan Gold (Tanzania) Private Limited" (DGTPL) in Tanzania on October 5, 2020.

Based on preliminary evaluation of information and desktop studies, DGTPL identified 5 Blocks and made application for Prospecting Licence (PL) to the mining authorities in Tanzania on October 9, 2020. All the 5 PL applications covering an area of 113.44 sq kms were granted and executed in February, 2021 after complying with the conditions of the Mining Commission, Tanzania. All the above 5 PLs are valid for a period of 4 years from the date of grant.
