- 59,26,196 (Fifty-Nine Lakh Twenty-Six Thousand One-Hundred and Ninety-Six) Equity Warrants ("Equity Warrants") for cash at an issue price of ₹ Rs. 191.90 (Rupees One hundred Ninety-One and Ninety Paise only) per Equity Warrant,

aggregating unto ₹137,67,36,464 (Rupees One hundred Thirty-Seven Crores Sixty-seven Lakhs Thirty-six Thousand Four Hundred Sixty-four only) ("**Total Issue Size**") belonging to non-promoter category on a preferential basis ("**Proposed Preferential Issue**"), The proposed preferential issue was approved at the meeting of Board of Directors of the Company held on August 07, 2026.

- ix. Draft notice of Extra Ordinary General Meeting including the disclosure in Explanatory Statement as required under Companies Act, 2013 & the Companies (Share Capital and Debentures) Rules, 2014 and Regulation 163(1) of the SEBI ICDR Regulations.
- x. Verified the relevant statutory records of the Company to confirm that:
 - a. it has no outstanding dues to the SEBI, the stock exchanges or the depositories except those whose are the subject matter of a pending appeal or proceeding(s), which has been admitted by the relevant Court, Tribunal or Authority.
 - b. it is in compliance with the conditions for continuous listing of equity shares as specified in the listing agreement with the stock exchange where the equity shares of the company are listed and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements), 2015, as amended, and any circular or notification issued by the Board thereunder.
